NOTIFICATION

No.Reg/UoL/Notification/Disc-R/Senate/2019/3776-75 In exercise of the powers conferred by sub-section (1) of Section 32 of the University of Loralai Act, 2012, and in pursuance of the approval accorded by the Senate of the University of Loralai in its 2nd meeting held on June 20, 2019, the University of Loralai is pleased to make, promulgate and notify the Disciplinary Rules.

Whereas the said Disciplinary Rules were duly approved by the Senate in accordance with the provisions of the University of Loralai Act, but owing to administrative reasons, could not be notified at the relevant time.

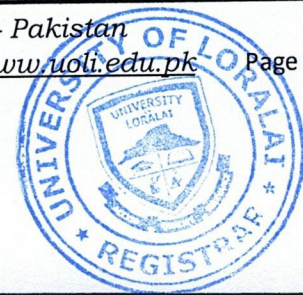
Now, therefore, with the ex post facto approval of the Competent Authority of the University of Loralai, the aforesaid Disciplinary Rules are hereby notified for general information and strict compliance.

It is further notified that all actions, proceedings and decisions taken in good faith under the said Disciplinary Rules after their approval by the Senate and before the issuance of this notification shall be deemed to have been validly taken, lawfully done and effectually enforced.

This notification shall be deemed to have taken effect from the date of approval by the Senate.

(1) The following shall constitute the acts of indiscipline:

- a) Use of indecent or uncivilized language, remarks or gestures within the varsity premises.
- b) Improper behavior, such as shouting, abusing, quarreling, fighting and manhandling on the campus.
- c) Carrying, using or threatening to use firearms and deadly weapons.
- d) Defiance of authority.
- e) Fake representation or giving false information or willful Concealment of the relevant information, cheating or deceiving.
- f) Inciting or staging a walkout, strike or an unauthorized procession or forming organization for sake of indulging in political activities.
- g) Shouting of slogans derogatory to the prestige of the university or the reputation of its officers or teachers.

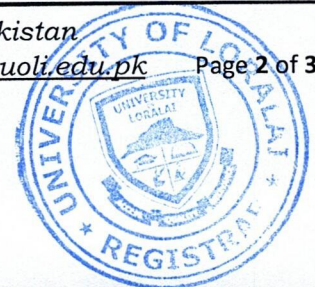

- h) Being found under the effect of an intoxicant.
 - i) Smoking within the University premises or university or while in the university transport.
 - j) Action defamatory of and derogatory to religion and Pakistan.
 - k) Use of unfair means in an examination.
 - l) Indulgence in activities prejudicial and detrimental to good order on the campus.
 - m) Unauthorized use of, or damaging university's moveable or immovable property or wall chalking.
 - n) All such other acts which the Competent Authority/ Discipline Committee may construe as breach of discipline.
- (2) Punishment or penalty for any of the offenses mentioned under above clauses shall be according to gravity of the case and may be one or more of the following:
- a) A record in the BOOK OF DISCIPLINE to be maintained by the Registrar's office, as detailed below:
 - First entry: Stern Warning
 - Second entry: Monetary Fine
 - Third entry: Expulsion
 - b) Fine as decided by the Discipline Committee.
 - c) Expulsion from the class., hostels for a specified period,
 - d) Detention from examination.
 - e) Cancellation of Examination results or withdrawal of certificate granted, and
 - f) Expulsion or rustication from the university for a specified period or for good.
- (3) The Department Chairs/ Directors/ Provosts shall be responsible for the maintenance of discipline among the students of their respective departments subject to the provisions of statutes and regulations of the university.
- (4) The certificates/ degree/ diplomas and other documents of a student involved in a case of breach of discipline may be withheld till the final disposal of the case.
- (5) Exceptional cases, not covered by the prescribed rules, shall be referred to the Syndicate by the Discipline Committee.
- (6) The Syndicate may consider the appeals of the students involved in the cases of breach of discipline on the recommendation of the Vice Chancellor.

- (7) Any student found guilty of committing any of the offences cited above shall automatically disqualify himself or herself from the award of any honor/ distinction from the university.
